Enclosed with this newsletter, you'll find a Covenant Review & Ballot Form, listing the changes that have been proposed. You'll also find a stamped envelope, addressed to the Association, to return your ballot in. Read the Review, mark your ballot, and send it back to us by November 30.

If you need to refer to the original CCR and By-laws, you can find them on WoodcreekMcHenry.org, on the 'Documents of Importance' page. Also on that page are the same documents with the combined changes, so that you can compare what was with what may be.

The need for these changes has been discussed for several years. Those changes have been mentioned in *The Woodcreek Promulgator* and debated in the quarterly meetings. Some owners (but not all) took the time to voice their opinions.

So please take some time to submit your ballot and mail it to us by November 30. We'll count the votes and post the results in early December.
