- **April 21, July 21, October 20** at the McHenry Moose Lodge, 3535 N. Richmond Road.

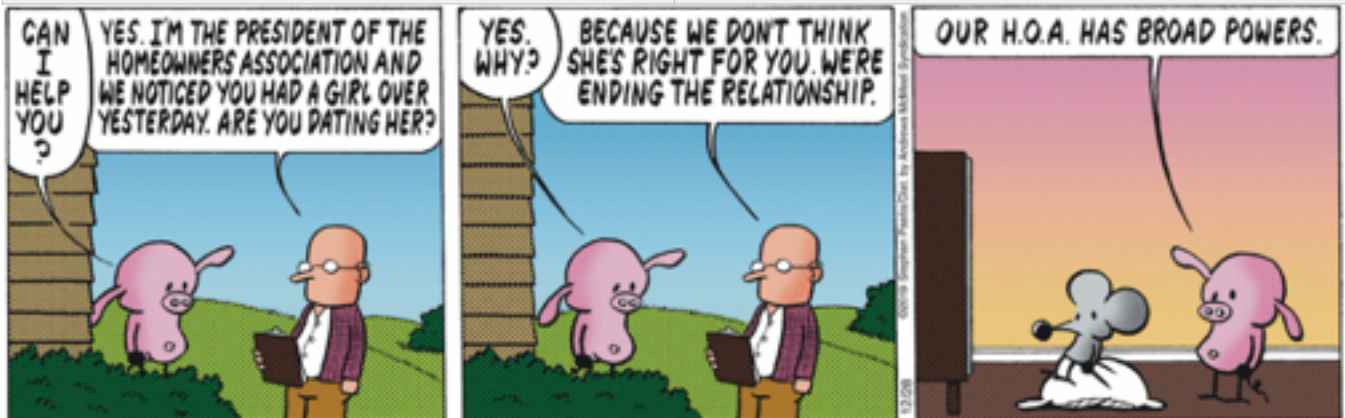
### ABOUT THE WOODCREEK PROMULGATOR
